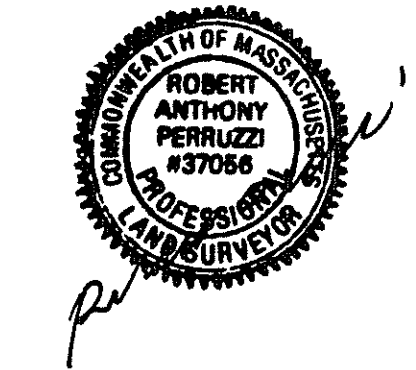


REGISTRY USE ONLY LOCUS MAP 1"=1000±

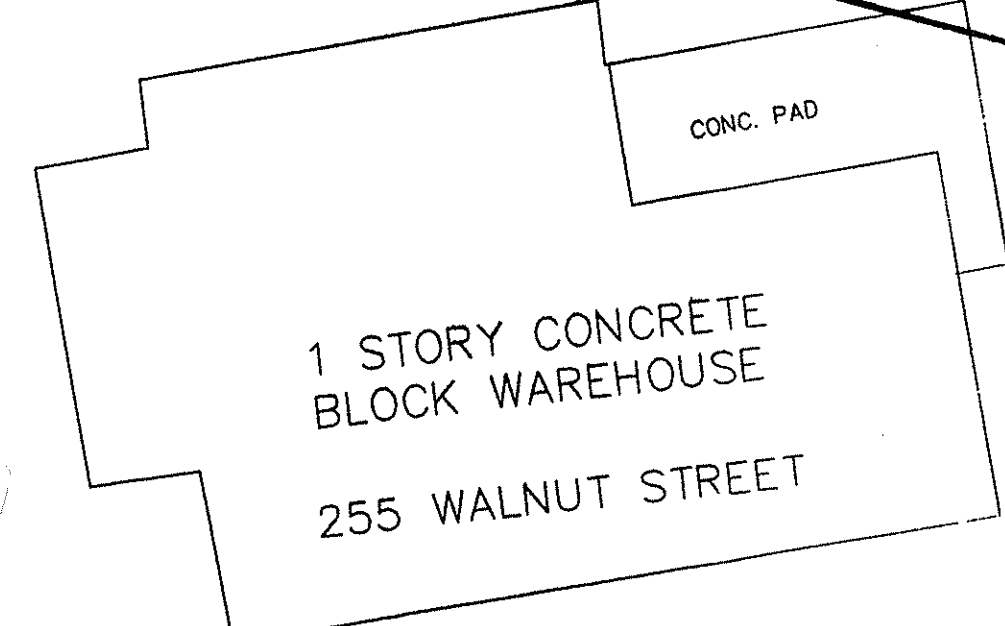

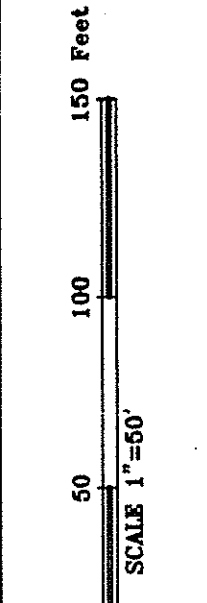
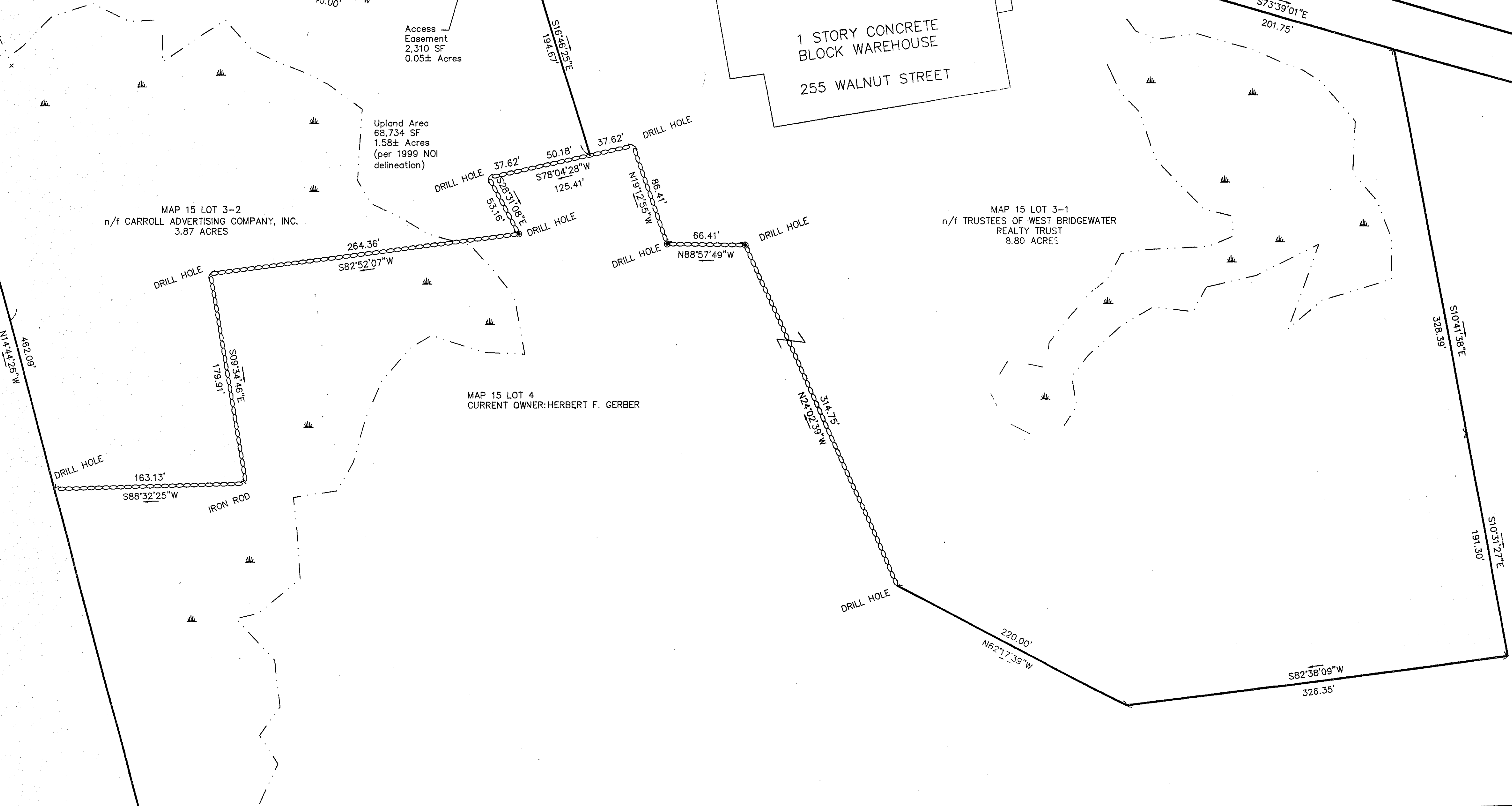
